

GENERAL ORDER 2020-010 Amendment 2

Order:

Pursuant to section 49(7) of the *Oil and Gas Activities Act* (the Act), I, Dax Bourke, amend General Order 2020-010 issued on April 23, 2020 to Tallahassee Exploration Inc. (Tallahassee);

1. by extending the deadline contained in item 3 for wells in Schedule B to **on or before** October 31st, 2021.

Conditions:

A. This order shall remain in effect until amended or terminated in whole or in part by the BC Oil and Gas Commission (Commission).

Reasons:

I make this order for the following reasons:

- i. On June 11,2021 the Commission and Tallahassee had a meeting to discuss the reactivation of some of the wells listed in Schedule B.
- ii. On July 5 and 6, 2021 the Commission granted approval to Tallahassee reactivate three disposal wells listed in Schedule B, WA 3474,7768 and 7517.
- iii. Tallahassee is continuing to implement measures for the reactivation of the other wells listed in Schedule B and has requested a further extension of the deadline.

iv. The Commission does not object to Tallahassee's proposed timeline to reactivate the wells listed in Schedule B by October 31, 2021 and considers an extension to the deadline appropriate in the circumstances.

Order:

Pursuant to section 49(7) of the *Oil and Gas Activities Act* (the Act), I, Patrick Smook, amend General Order 2020-010 issued on April 23, 2020 to Tallahassee Exploration Inc. (Tallahassee);

1. by extending the deadline contained in item 3 for wells in Schedule B to **on or before** March 31st, 2021.

Conditions:

A. This order shall remain in effect until amended or terminated in whole or in part by the BC Oil and Gas Commission (Commission).

Reasons:

I make this order for the following reasons:

- i. Tallahassee and the Commission had a meeting on May 21st, 2020 where Tallahassee proposed plans for the reactivation of the wells listed in Schedule B.
- ii. Tallahassee submitted an alternative suspension plan on June 23rd, 2020 for wells WA 3474, WA 7768, and WA 7517 to the Commission including monthly monitoring and reporting of casing and tubing pressures, and monthly pressure testing of seals, pending reactivation.
- iii. Tallahassee communicated an update on October 29th, 2020 to the Commission of their reactivation plans of wells listed in Schedule B.

iv. The Commission does not object to Tallahassee's proposed timeline to reactivate the wells listed in Schedule B in March 2021 and considers an extension to the deadline appropriate in the circumstances.

GENERAL ORDER 2020-010

Order:

Pursuant to section 49(1) (d) of the *Oil and Gas Activities Act* (the Act), I, Patrick Smook, order that Tallahassee Exploration Inc. (Tallahassee) must:

- 1. For any well listed in the attached Schedule A that has been suspended in accordance with section 25(5) of the Drilling and Production Regulation (DPR), submit a well suspension report to the BC Oil and Gas Commission (Commission) via eSubmission portal by May 23, 2020.
- 2. Suspend, in accordance with section 25(5) of the DPR, or alternatively, reactivate or abandon, WA 8744 and WA 8793 listed in Schedule A, by June 23, 2020.
- 3. Suspend in accordance with section 25(5) of the DPR, or alternatively, reactivate or abandon, the remainder of the wells listed in Schedule A, by August 23, 2020.
- 4. For each well suspended under items 2 and 3 above, submit a well suspension report to the Commission via eSubmission portal within 30 days of the suspension.

Conditions:

A. This order shall remain in effect until amended or terminated in whole or in part by the BC Oil and Gas Commission.

Reasons:

I make this order for the following reasons:

- i. Tallahassee is the permit holder for each of the inactive wells listed in Schedule A.
- ii. Section 25(5) of the DPR requires a well permit holder of an inactive well, within 60 days of the well becoming inactive, to do both of the following:

- (a) suspend the well in a manner that ensures the ongoing integrity of the well;
- (b) ensure positive isolation between the well and the flowline by disconnecting the well from the flowline or by other means.
- iii. Section 25(2) of the DPR requires a well permit holder of an inactive well to submit a report to the Commission within 30 days of the suspension of a well.
- iv. On December 27, 2018 Tallahassee submitted to the Commission a proposed plan to suspend or reactivate inactive wells including those listed in Schedule A on timelines ending on September 30, 2019.
- v. On January 15, 2019 the Commission issued an exemption to Tallahassee, under section 4(1) of the DPR, from section 25(5) of the DPR for 16 of the 20 wells listed in Schedule A valid until September 30, 2019.
- vi. A search of Commission records indicates that Tallahassee has not submitted suspension reports for the wells listed in Schedule A as required under section 25(2) of the DPR.
- vii. I am of the opinion that Tallahassee is not in compliance with section 25 of the DPR.

Review and Appeal
