GENERAL ORDER 2022-0029-01

Section 49 Oil and Gas Activities Act

Issued to:

Pavilion Energy Corp. 1100, 800 - 6th Avenue, SW Calgary, Alberta T2P 4M6

Attention: Mr. Russell Gonie

Order:

Pursuant to section 49(1)(e)(ii) of the *Oil and Gas Activities Act* (the Act), I, Dax Bourke, order that Pavilion Energy Corp. (Pavilion) must:

- 1. No later than April 9, 2022, cease any transport of fluids through pipeline project number 2988 segment 3 (the Pipeline).
- 2. No later than June 15, 2022, complete an engineering assessment of the Pipeline in accordance with CSA Z2662, or abandon the pipeline in accordance with the Pipeline Regulation.
- 3. On or before 04:30 P.M. (PDT) April 10, 2022, provide notification of completion of Item 1 electronically to the Oil and Gas Commission (Commission) at C&E@bcogc.ca.
- 4. On or before 04:30 P.M. (PDT) June 15, 2022, provide notification of completion of Item 2 electronically to the Commission at C&E@bcogc.ca.

Conditions:

A. This order shall remain in effect until amended or terminated in whole or in part by the Commission.

Reasons:

I make this order for the following reasons:

- i. Pavilion is the permit holder for the Pipeline.
- ii. On March 22, 2022, the Pipeline ruptured, resulting in a spill of approximately 20 cubic meters of liquid hydrocarbons.
- iii. The Pipeline rupture appears to have been caused by an overpressure event.
- iv. The apparent overpressure may have permanently damaged the Pipeline.

- v. An engineering assessment is required to determine if the Pipeline can be safely returned to service.
- vi. I am of the opinion that this order is necessary to protect the environment.

Review and Appeal:

Pavilion may request a review of this order under section 70 of the Act by submitting a request for review to: ogc.determinationreviews@bcogc.ca.

Alternatively, Pavilion may appeal this order to the Oil and Gas Appeal Tribunal under section 72 of the Act. The process for appeals may be found at www.ogat.gov.bc.ca and a notice of appeal may be sent to the Oil and Gas Appeal Tribunal at:
