Order:

Pursuant to section 38(1)(c) of the *Oil and Gas Activities Act* (the Act), I, Kevin Parsonage, order that Pavilion Energy Corp. (Pavilion) must:

1. For each survey completed in accordance with section 41.1 of the Drilling and Production Regulation, prepare a record for each well listed in Schedule A and for each facility listed in Schedule B of the information required by section 41.1(7) of the Drilling and Production Regulation for the calendar year 2021.
2. For each well listed in Schedule A and each facility listed in Schedule B that was inactive, or active for a portion only of the calendar year 2021, prepare a record indicating the number of days each well or facility was active or inactive as applicable during the calendar year 2021.

Request:

Pursuant to section 38(1)(e) of the Act, the Commission requests that Pavilion submit a copy of the records referred to in items 1 and 2 in spreadsheet form, by no later than September 15, 2022 electronically to C&E@bcogc.ca.

- II. Amended or terminated by the Commission.
