Order:

Pursuant to section 38(1)(c) of the *Energy Resource Activities Act* (the Act), I, Robert Workman, order that Pacific Northern Gas Ltd. (PNG) must:

- 1. Prepare a report, completed by a Qualified Professional, detailing the works and the minimum required timelines, with supporting rationale, required to mitigate geotechnical and hydrotechnical risks at BGC Site # 277, which is described in the BGC Engineering Inc. report entitled "Pipeline Network-Wide Compilation of Geohazard Assessments" dated March 17, 2025, BGC project #0149030, located on pipeline project 26025 segment 2.
- 2. Prepare a report, completed by a Qualified Professional, detailing the results of site investigations to assess hydrotechnical and geotechnical risks for the locations specified in Appendix A.
- 3. Prepare a report, completed by a Qualified Professional, that identifies the required corrective action(s), timelines and supporting rationale, to mitigate geotechnical and hydrotechnical risks and address pipeline exposures for the locations specified in Appendix B.
- 4. Prepare a report, completed by a Qualified Professional, detailing the results of engineering assessments, in accordance with CSA Z662:23 Oil and Gas Pipeline Systems, clause 10.1, for BGC Sites #439 and #343, as described in the BGC Engineering Inc. report entitled "Pipeline Network-Wide Compilation of Geohazard Assessments" dated March 17, 2025, BGC project #0149030, located along pipeline project 26207 segment 5.

Request:

Pursuant to section 38(1)(e) of the Act, the BCER requests that PNG submit a copy of the records referred to in item 1, no later than June 20, 2025, electronically to <u>C&E@bc-er.ca</u>.



Pursuant to section 38(1)(e) of the Act, the BCER requests that PNG submit a copy of the records referred to in items 2, 3 and 4 no later than October 31, 2025, electronically to <u>C&E@bc-er.ca</u>.

This order shall remain in effect until:

- I. All directives in this order have been completed as required, or
- II. Amended or terminated by the BC Energy Regulator.
