General Order 2018 – 101 issued to Shell Canada Limited (Shell) is hereby amended as follows. All other aspects of the order are unchanged.

**Order:**

By replacing item 5 in the original order with the following:

5. Modify the existing outlet or construct a new outlet on Pit 3 to ensure that:
  - a. the maximum water level that the pit will be able to store is lowered by 0.5 meters, and
  - b. the outlet and areas where water flows are stable, and

**Reasons:**

By replacing item iv in the original reasons with the following:

- iv. Compliance with this order will ensure that Pits 1 and 3 are no longer dams to which Part 2 of the Dam Safety Regulation applies and that water from streams is no longer being diverted into Pit 1.

**Order:**

Pursuant to section 93(2)(d) and 93(2)(e)(i) of the Water Sustainability Act (the Act), I, James O’Hanley, as a water manager designated under section 114(3) of the Act, order that Shell Canada Limited (Shell) must in relation to the works located within District Lot 2615 and depicted on the attached drawing as Water Pit #1 (Pit 1), Water Pit #3 (Pit 3), 802m Catch Ditch and 683m Catch Ditch:

1. Dewater, decommission and reclaim the works identified as Pit 1 to the satisfaction of an officer or engineer employed by the BC Oil and Gas Commission (the Commission),
2. As part of the decommissioning and reclamation of Pit 1, ensure that the stream originally diverted into the works is diverted into the 802m Catch Ditch in a manner that is stable and prevents erosion,
3. Fill in and reclaim the 683m Catch Ditch in a manner that ensures that it no longer diverts water from the non-classified drainage (NCD) and does not concentrate water flows onto the reclaimed area of Pit 1,
4. Remove the two culverts diverting water from the adjacent land into Pit 3 and remediate any disturbance caused by the removal,
5. Modify the outlet of Pit 3 to ensure that:
  - a. the maximum water level that the pit will be able to store is lowered by 0.5 meters, and
  - b. ensure the outlet is stable and allows overflow from the pit to drain into the adjacent constructed ditch, and
6. Ensure overflows from the 802m Catch Ditch and Pit 3 are able to flow into Townsend Creek.

**Conditions:**

- A. Unless a later date is specified by a water manager appointed under the Act, all aspects of the order must be completed by October 31, 2018.

**Reasons:**

- i. The works identified as Pits 1 and 3 have been determined to be dams to which Part 2 of the Dam Safety Regulation applies.
- ii. Water is being diverted from streams into each of the Pits.
- iii. Shell undertook the construction of the works and diversion of the streams and does not hold the required authorizations under the Act or the Dam Safety Regulation to divert the water or construct and operate the Pits as dams.
- iv. Compliance with this order will ensure that Pits 1 and 3 are no longer dams to which Part 2 of the Dam Safety Regulation applies and that water from streams is no longer being diverted into these structures.

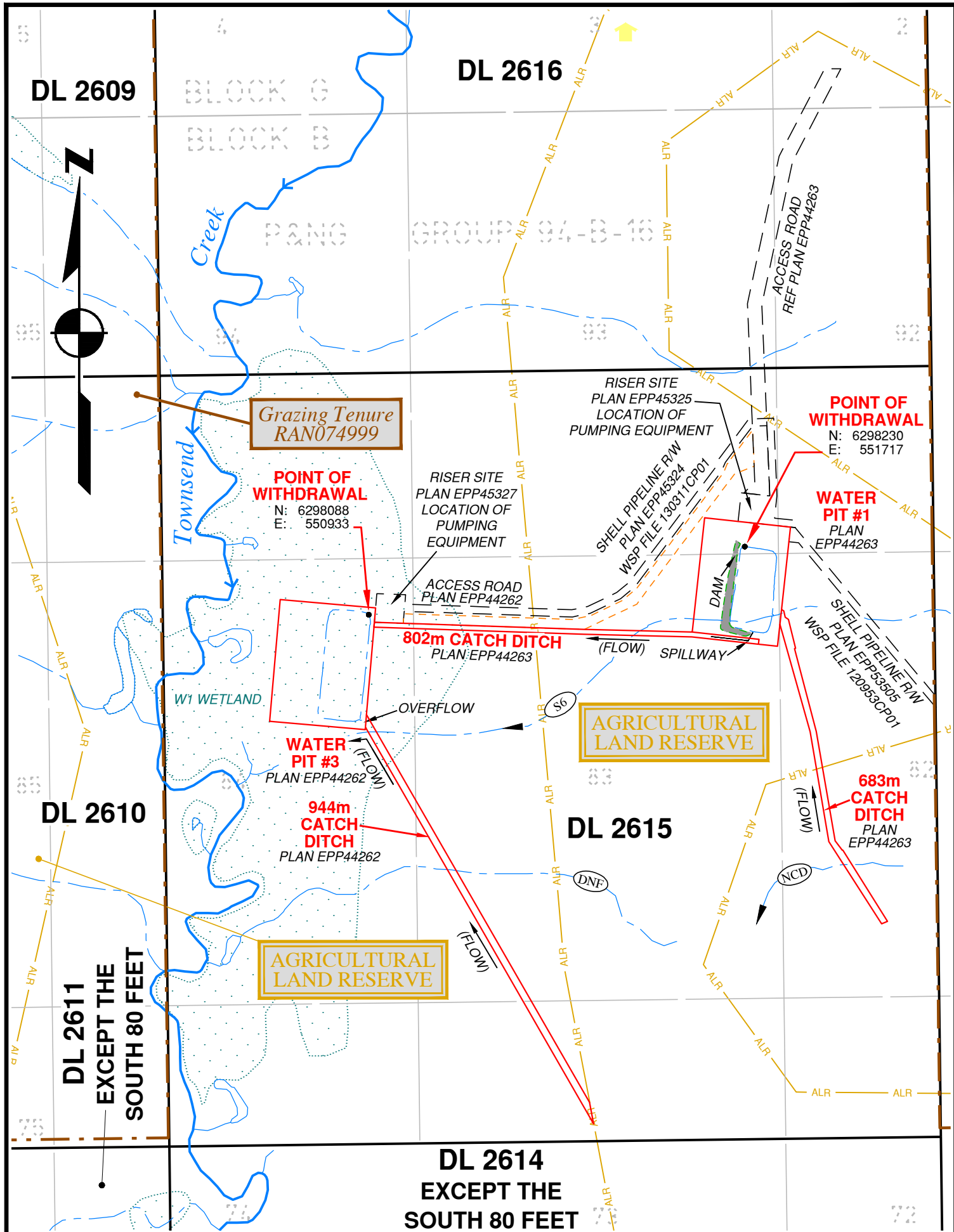
