Order:

Pursuant to section 49(7) of the *Oil and Gas Activities Act* (the Act), I, Patrick Smook, amend General Order 2018-006 issued on April 27, 2018 to Primavera Resources Corp (Primavera) as follows:

1. The date in item 1 is amended to on or before May 18, 2018.
2. The date in item 2 is amended to on or before June 15, 2018.

Conditions:

- A. This order shall remain in effect until amended or terminated in whole or in part by the Commission.

Reasons:

I amend this Order for the following reasons:

- i. Primavera has requested more time to complete an electromagnetic survey of the lease and surface run-off area adjacent to the lease followed by a defined sampling program scheduled for May 8-9, 2018 by an environmental consultant.
- ii. Removal of impacted soil will be initiated following receipt of analysis and as local road bans permit.
- iii. Submission of preliminary sampling and testing results is required in an expedited manner to allow the Commission to understand the extent of contamination.
- iv. I am of the opinion the amended timelines are reasonable.

Review and Appeal:

Primavera may request a review of this order under section 70 of the Act by submitting a request for review to ogc.determinationreviews@bcogc.ca.

Order:

Pursuant to section 49(1)(a) and (b) of the *Oil and Gas Activities Act* (the Act), I, Patrick Smook, order that Primavera Resources Corp. (Primavera) must:

1. On or before May 7th, 2018:
 - a) Sample the soils and fluid on and off lease, using a Qualified Professional and following applicable land use standards to delineate the area impacted as a result of the flow of surface runoff from the Primavera lease located 6-13-84-21 W6M (the lease). Soil and fluid samples must then be analyzed by an accredited laboratory for detailed salinity (routine chemistry for surface water), Contaminated Sites Regulation (CSR) metals (total metals for surface water), volatile petroleum hydrocarbons (VPH), light extractable petroleum hydrocarbons (LEPH), heavy extractable petroleum hydrocarbons (HEPH), benzene, toluene, ethylbenzene and xylenes (BTEX).
 - b) Remove the visible stained soil on the lease around the pump jack.
 - c) The results of soil and water analysis must be submitted electronically to the Compliance and Enforcement mailbox at C&E@bcogc.ca.

2. On or before May 29th, 2018:
 - a) Provide the Oil and Gas Commission (the Commission) with a report (the Report) that includes: all the analytical data from the samples collection described in Item 1a); a diagram detailing the extent of the impacts; a summary of actions undertaken in the response to the flow of fluid from the lease; and, evidence that affected soil has been removed.
 - b) The Report must be submitted electronically to the Compliance and Enforcement mailbox at C&E@bcogc.ca.

Conditions:

- A. Activities off lease required under this Order are subject to land owner consent.
- B. This order shall remain in effect until amended or terminated in whole or in part by the Commission.

Reasons:

I make this Order for the following reasons:

- i. Primavera is the permit holder of the lease.
- ii. On April 13th, 2018 a spill of four cubic meters of emulsion was discovered near the base of the pump jack located on the lease.
- iii. On April 13th, 2018 an Oil and Gas Operations Officer conducted a site inspection while clean up was taking place and requested further clean up efforts be made.
- iv. On April 25th, 2018 Oil and Gas Operations Officers noticed visible staining, a sheen on the pooled surface water and animal tracks at the lease.
- v. On April 25th, 2018 Oil and Gas Operation Officers also observed evidence of the breached berm on the lease where surface runoff was leaving the lease.
- vi. I am of the opinion that this order is necessary to protect the environment.
- vii. I am of the opinion that Primavera has failed to comply with the 37(2)(b) and (c) of the Oil and Gas Activities Act.

Review and Appeal:

Primavera may request a review of this order under section 70 of the Act by submitting a request for review to ogc.determinationreviews@bcogc.ca.
