Trees or portions of these trees that can be accessed from the activity area without causing damage to standing timber may be harvested.

Water Course Crossings and Works

- 7. Stream, lake and wetland crossings must be constructed in accordance with the methods and any mitigations, as specified in the application.
- 8. At any time, the Commission may suspend instream works approved under this permit. Suspensions on instream works will remain in place until such time as the Commission notifies permit holders that works may resume. Reasons for suspension of works may include, but are not limited to, drought conditions and increased environmental or public safety risks.
- 9. Equipment used for activities under this Permit must not be situated in a stream channel unless it is dry or frozen to the bottom at the time of the activity.

Trees or portions of these trees that can be accessed from the activity area without causing damage to standing timber may be harvested.

Water Course Crossings and Works

- 8. Except with leave of the Commission, and subject to relevant access permissions, the Approval Holder must conduct water quality monitoring during in-stream works and the results of that monitoring must be submitted to the Commission upon the Commission's request.
