Changes to Fee, Levy and Security Regulation

TO: Industry Clients

EFFECTIVE DATE: Feb. 6, 2014

BACKGROUND:

The Fee, Levy and Security Regulation (FLSR) under the Oil and Gas Activities Act (OGAA) is the tool by which the BC Oil and Gas Commission (Commission) acquires funds to meet its regulatory obligations and recover expenses. Current fees, levies, and securities are noted in the FLSR under OGAA.

A review has resulted in changes to the FLSR that will take effect starting Feb. 6, 2014. An Appendix has been provided at the end of this bulletin detailing the pending changes, new categories and resulting fee schedule.

PENDING CHANGES:

Starting Feb. 6, 2014 applications submitted to the Commission will be subject to the new fee schedule. The following fee and levy revisions and new category examples provided below do not reflect all pending changes. Clients are encouraged to refer to the attached Appendix for the full schedule.

As of the effective date, the revised well permit application fee will be:

• \$12,400 for existing permit holders, as well as first time permit holders. \$600 of this fee will be used to fund the Science and Community Environmental Knowledge Fund (SCEK).

As of the effective date, the revised levies will be:

- \$1.45 per cubic metre of petroleum (\$0.12 of this will fund SCEK)¹.
- \$0.73 per thousand cubic metres of marketable gas (\$0.06 of this will fund SCEK)².

These new rates will appear on producers' Feb. 7, 2014 invoices.

MAJOR PROJECT FEES:

Due to new facility and pipeline classifications, and the increased technical nature of major project applications, the revised FLSR will reflect new fee categories to support the time required to efficiently review and process the applications. Some examples of these fees are as follows:

CLASS C LNG Facilities

- Permit Application: \$650,000
- Post-design Amendment: \$350,000
- Major Amendment: \$15,000

For additional information on Class A and B facilities, as well as minor and major amendment fees, please refer to the attached Appendix.

ROADS:

As a result of the enactment of the Oil and Gas Road Regulation (OGRR) under OGAA, the Commission will be issuing permits for oil and gas roads:

- Winter access roads \geq 5 km permit application: \$100/km
- All season access roads ≥ 5 km permit application: \$200/km
- Road ≥ 5 km major amendment application: \$500

For all other permit and amendment application fees and new fee categories effective on Feb. 6, 2014 please refer to the attached Appendix.

It is recommended clients familiarize themselves with the pending FLSR changes and ensure payments are accurate when submitting applications; if there is any uncertainty regarding calculations it is the applicant's responsibility to contact the Commission for assistance. Applications submitted prior to the effective date that are declined and resubmitted after Feb. 6, 2014 may be subject to the new fee schedule, as advised by the Commission.

Support materials (such as pipeline application <u>manuals</u>), and KERMIT/IRIS will reflect the FLSR changes on the effective date.
