

Quarterly Enforcement Action Summary

Order

Issued if there is a failure to comply with the Oil and Gas Activities Act (OGAA), associated regulations, permits or authorizations, or a previous order. Orders may also be issued to protect public safety or the environment, or to promote the conservation of petroleum and natural gas resources. Orders are available on the Compliance and Enforcement page of the Commission website.

Contravention Decision

A decision made on whether a contravention of OGAA, associated regulations, permits or authorizations, or previous orders has occurred. An administrative penalty may be levied in accordance with the Act and Administrative Penalties Regulation.

Definitions

Order Terminated:

Once the Commission is satisfied the circumstances giving rise to an order have been addressed or are no longer present, the Commission may terminate the order.

Compliance Ongoing:

This covers situations where a permit holder is working to comply with the requirements laid out in the order. The enforcement process remains active and open.
