RE: PRESSURE MAINTENANCE WATERFLOOD CANCELLATION WEASEL FIELD – HALFWAY FORMATION – UNIT #2

The Commission is presently reviewing and amending waterflood approvals to conform to current requirements. The waterflood project in the Weasel field, Halfway formation, approved on June 24th, 1968, has been reviewed by Commission staff. Table 1 lists the completed wells in the subject project. Commission records for the project indicate that water injected ceased in February 1994. On August 25th, 2020, Canadian Natural Resources Limited indicated to the Commission via email that they had no plans to restart injection operations and concurred that cancellation of the approval is appropriate.
