RE: PRESSURE MAINTENANCE GAS INJECTION PROJECT CANCELLATION STODDART WEST FIELD – BELLOY 'C' POOL

The Commission is presently reviewing and amending pressure maintenance gas injection project approvals to conform to current requirements. The pressure maintenance gas injection project in the Stoddart West field, Belloy 'C' pool, approved on July 4th, 1990, has been reviewed by Commission staff. Table 1 lists the completed wells in the subject project. Commission records for the project indicate that gas injection ceased in April of 2007. On January 12th, 2021, Pavilion Energy Corp. indicated to the Commission via email there is no plan to start injection operations and concurred that cancellation of the approval is appropriate.
