

IN THE MATTER of a scheme of Newalta Corporation (Newalta) for Disposal of Non-Special Waste (NSW) in the Debolt Formation in the well Newalta Ft St John SE 12-10-83-17 W6M (WA 5407).

NOW, THEREFORE, pursuant to Part 8, Division 3, section 94 (previously section 97) of the Drilling and Production Regulation, the NSW disposal approval is hereby amended, as such scheme is described in

an application from Newalta to the Commission dated February 1, 2001.

1. The disposal interval must be in the Debolt Formation.
2. A record of volume of NSW stream by component disposed of through this well must be included on a Monthly Injection/Disposal Statement, in the prescribed form (BC-S18), which must be submitted to the Commission not later than the 25th day of the month following the reported month.
3. A copy of the Reporting of the Permit PE-14924 requirement (item 7) by Ministry of Environment, Lands and Parks must also be submitted to the Commission.
4. The disposal/injection pressure at the sandface must not exceed the formation fracture pressure.
5. This approval may be modified or rescinded at a later date if deemed appropriate through a change in circumstances.
