**RE: APPLICATION TO AMEND PRESSURE MAINTENANCE APPROVAL
BRASSEY - ARTEX "A", "B", "D" AND "G" POOLS**

The Commission has reviewed your application dated June 21, 2004 wherein you requested to reduce the minimum operating pressure of the Brassey Artex "D" pool.

We would like to thank the Burlington staff for meeting with us in Victoria on June 29, 2004 to update on production performance of the Brassey Artex "D" pool.

This is a mature pool where the performance has been closely following reservoir model prediction. Based on the review, it is concluded that reducing the operating pressures will not adversely impact the oil recovery. Therefore, your proposal to reduce the Artex "D" pool operating pressure to 500 kPa is considered appropriate. Consequently, condition #6 of the pressure maintenance scheme by gas reinjection granted under section 116 (now section 100) of the Petroleum and Natural Gas Act on June 29, 1989, with last amendment of June 4, 2003 is hereby amended as follows:

- 6. Average reservoir pressure will be maintained above 500 kPa in "B" pool, above 500 kPa in "D" pool and above 50 kPa in "G" pool.

Please note that there is no longer a requirement for submitting a progress report. All other conditions of the approval remain unchanged.
