**RE: : APPLICATION TO AMEND PRESSURE MAINTENANCE APPROVAL
BRASSEY ARTEX "A", "B", "D" AND "G" POOLS**

The Commission acknowledges receipt of your application dated April 27, 2000 requesting that the pressure maintenance approval in the Brassey Artex "B" pool be amended to allow conversion of Canhunter Brassey d-44-F/93-P-10 (WA 7036) into an injection well.

Your proposal to complete the well d-44-F as an injector is considered appropriate as it may contact unswept portions of the pool thereby improving the ultimate recovery of oil. Consequently, condition #2 of the pressure maintenance scheme by gas reinjection granted under section 116 (now section 100) of the Petroleum and Natural Gas Act on June 29, 1989, subsequently amended on April 6, 1990, February 20, 1991, September 2, 1993, February 8, 1994, December 10, 1997 and on July 29, 1998 is hereby amended as follows:

- 2. All produced gas in excess of that required for lease fuel will be injected into the gas injection wells. Produced gas may be injected into the following wells:

Pool "A": d-89-B/93-P-10

Pool "B": d-13-F, c-34-F, d-44-F and d-55-F in 93-P-10 and 13-1-77-19 W6M.

Pool "D": d-A71-C and a-82-C in 93-P-10.

Pool "G": d-93-C/93-P-10

Additional and alternate injectors or producers may be approved on application.

All other conditions of the approvals remain unchanged.
