RE: PRESSURE MAINTENANCE WATERFLOOD CANCELLATION MILLIGAN CREEK FIELD – HALFWAY "A" POOL UNIT #2

The Commission is presently reviewing and amending waterflood approvals to conform to current requirements. The waterflood project in the Milligan Creek field, Halfway 'A' pool, Unit #2, approved on May 23, 1973, has been reviewed by Commission staff. Table 1 lists the completed wells in the subject Unit. Commission records for the project indicate that water injected ceased in August 2015. On February 6th, 2020, Canadian Natural Resources Limited indicated to the Commission via email that they had no plans to restart injection operations and concurred that cancellation of the approval is appropriate.
