**Re: WATERFLOOD PRESSURE MAINTENANCE APPROVAL, AMENDMENT #4
BOUNDARY LAKE - BOUNDARY LAKE "A" POOL, PRIMEWEST PROJECT #1**

The Commission has reviewed your application dated March 25, 2004 requesting that the well 2-3-86-14 (WA# 1666), a currently suspended oil producer within the subject project, be converted to a water injector.

Based on a review of the production/injection performance, we concur that addition water injectivity in this portion of the pool will likely result in additional oil recovery, without adversely impacting competitive operations. Accordingly, attached is Approval 64-09-004 (Amendment #4) for the application, granted under Section 100 of the Petroleum and Natural Gas Act.


IN THE MATTER of a pressure maintenance scheme of Primewest Energy Inc. (Primewest) for waterflood recovery of oil by water injection into a portion of the Boundary Lake – Boundary Lake “A” Pool.

The approval granted pursuant to Section 100 (previously Section 116) of the Petroleum and Natural Gas Act, R.S.B.C. 1996, c.361 is hereby amended as follows:

The pressure maintenance scheme for waterflood recovery of oil from the Boundary Lake – Boundary Lake “A” Pool as approved July 22, 1964 and amended September 25, 1964, September 16, 1965 and May 16, 1968 is hereby amended, subject to the terms herein contained:

1. The project area of the pressure maintenance scheme consists of:

Twp 85 Rge 14 W6M- S/2 sec 22, sec 26, N/2 sec 34, sec 35
Twp 86 Rge 14 W6M - sec 2, S/2 sec 3, E/2 sec 11 and E/2 sec 14.
2. The project daily oil allowable is 782.1 m³.
3. Water may be injected into the Boundary Lake – Boundary Lake “A” pool through the wells located at 6-26, 16-26, 16-34, 6-35, 16-35-85-14 and 16-2, 2-3, 16-11-86-14 W6M.
4. The injection pressure measured at the sandface must not exceed the formation fracture pressure.
5. An oil well may be drilled anywhere within the project area provided that it is not nearer than 100 m to the sides of the project area.
6. The operations of the pressure maintenance scheme will be subject to periodic review and modification to the approval may be ordered, if deemed appropriate.
